2. Job-Order Costing: Calculating Unit Product Costs

- 2.1 Compute and apply a predetermined overhead rate to jobs
- 2.2 Compute the total cost and the unit product cost of a job using plantwide and multiple departmental predetermined overhead rates
- 2.3 Understand the implications of basing the predetermined overhead rate on activity at capacity rather than on estimated activity for the period

3. Job-Order Costing: Cost Flows and External Reporting

- 3.1 Understand the flow of costs in a job-order costing system and prepare appropriate journal entries to record costs
- 3.2 Use T-accounts to show the flow of costs in a job-order costing system
- 3.3 Prepare schedules of cost of goods manufactured and cost of goods sold and an income statement
- 3.4 Compute underapplied or overapplied overhead cost and prepare the journal entry to close the balance in Manufacturing Overhead to the appropriate accounts

4. Process Costing

- 4.1 Record the flow of materials, labor, and overhead through a process costing system.
- 4.2 Compute the equivalent units of production using the weighted-average method
- 4.3 Compute the cost per equivalent unit using the weighted-average method
- 4.4 Assign costs to units using the weighted-average method
- 4.5 Prepare a cost reconciliation report
- 4.6 Allocate service department costs to operating departments using the direct method
- 4.7 Allocate service department costs to operating departments using the step-down method

5. Cost-Volume-Profit Relationships

- 5.1 Explain how changes in sales volume affect contribution margin and net operating income
- 5.2 Prepare and interpret a cost-volume-profit (CVP) graph and a profit graph

- 5.3 Use the contribution margin ratio (CM ratio) to compute changes in contribution margin and net operating income resulting from changes in sales volume
- 5.4 Show the effects on contribution margin of changes in variable costs, fixed costs, selling price, and volume
- 5.5 Determine the level of sales needed to achieve a desired target profit
- 5.6 Determine the break-even point
- 5.7 Compute the margin of safety and explain its significance
- 5.8 Compute the degree of operating leverage at a particular level of sales and explain how it can be used to predict changes in net operating income
- 5.9 Compute the break-even point for a multiproduct company and explain the effects of shifts in the sales mix on contribution margin and the break-even point

6. Variable Costing and Segment Reporting: Tools for Management

- 6.1 Explain how variable costing differs from absorption costing and compute unit product costs under each method
- 6.2 Prepare income statements using both variable and absorption costing
- 6.3 Reconcile variable costing and absorption costing net operating incomes and explain why the two amounts differ
- 6.4 Prepare a segmented income statement that differentiates traceable fixed costs from common fixed costs and use it to make decisions
- 6.5 Compute companywide and segment break-even points for a company with traceable fixed costs

7. Activity-Based Costing: A Tool to Aid Decision Making

- 7.1 Understand activity-based costing and how it differs from a traditional costing system
- 7.2 Assign costs to cost pools using a first-stage allocation
- 7.3 Compute activity rates for cost pools
- 7.4 Assign costs to a cost object using a second-stage allocation
- 7.5 Use activity-based costing to compute product and customer margins

8. Master Budgeting

- 11.3 Determine the range, if any, within which a negotiated transfer price should fall
- 11.4 Charge operating departments for services provided by service departments

12. Differential Analysis: The Key to Decision Making

- 12.2 Prepare an analysis showing whether a product line or other business segment should be dropped or retained

- 12.5 Determine the most profitable use of a constrained resource and the value of obtaining more of the constrained resource
