Experience in preventive, supportive, and therapeutic care is offered through clinical experience in the care of the obstetrical patient, newborn, child and adolescent. Students are provided the opportunity to utilize critical thinking, the nursing process, nursing skills, and management skills in various health care settings.

COURSE TOPICS AND CONTENT REQUIREMENTS:

- Introduction to family-centered nursing of children (current trends)
- History and trends in obstetrics.
- Review of reproductive anatomy and physiology.
- Identify changes and conditions in the female body systems throughout the lifespan.
- Fetal development (conception through birth; focusing on change by trimester).
- Prenatal care.
- Family adaptation and preparation for birth of a child.
- Nutrition in pregnancy.
- Labor and delivery including medications commonly used, and electronic fetal monitoring.
- Infant feeding methods
- The newborn (immediate care after birth, normal variations).
- Postpartum care (normal assessments).
- Adolescent pregnancy.
- Complications of pregnancy and in the newborn.
- Legal & ethical issues in maternal child nursing.
- Informatics in the childbearing family setting.
- Nursing intervention to meet psychological needs of the ill/hospitalized child and family.
- Health promotion for the child (immunizations, review safety, anticipatory guidance).

- 1.3. Identify how evaluation may lead to revision or modification in the woman's plan of care.
- 1.4. Describe ways to incorporate patient/family teaching with routine care.
- 1.5. Describe and perform nursing interventions, which meet the needs of the members of the childbearing family.
- 1.6. Analyze legal/ethical situations pertinent to the childbearing family and practice within professional standards.
- 1.7. Discuss the "Standards of Practice" as established by ANA, AWHONN, hospital policy, and the current Illinois Nurse Practice Act.
- 1.8. Describe the current Illinois laws regarding consent for the treatment of minors.
- 1.9. Describe the importance of the attitude of the nurse in providing care to the childbearing family.

Outcome 2: Integrate therapeutic communication techniques when interacting with clients, their aggregates, and health care team members in maternal-child health care settings.

- 2.1. Identify communication strategies for interacting with all members of the childbearing family.
- 2.2. Describe communication strategies for communication with children of different ages.
- 2.3. Identify attitudes, values and beliefs which my influence therapeutic communication with the childbearing family.
- 2.4. Describe communication techniques to facilitate the grieving process for a family experiencing premature birth, fetal or infant death, or an infant with congenital anomalies.

2.6. Demonstrate empathy and caring when interacting with the childbearing family.

Outcome 3: Integrate the clients' biophysical adaptation in response to various therapies used for health promotion, maintenance, and restoration for the childbearing family.

- 3.1. Identify common teratogens and describe their potential effects on the embryo and fetus.
- 3.2. Identify changes and conditions in the female body systems throughout the lifespan.
- 3.3. Identify the nutritional needs of the members of the childbearing family.
- 3.4. Describe the methods of contraception, their effectiveness, advantages and disadvantages of each.
- 3.5. Identify medications given during antepartum, intrapartum, and postpartum stages, their side effects, route of administration, and nursing implications.
- 3.6. Perform a physical exam appropriate to the infant/child's age.
- 3.7. Identify the stressors of illness and hospitalization for children and their family during the different developmental stages.
- 3.8. Demonstrate safety measures important in the plan of care for members of the childbearing family.
- 3.9. Identify the effects of socioeconomic status and cultural backgrounds on the childbearing experience.
