I. CATALOG DESCRIPTION

In the therapeutic massage clinical setting, massage students have the opportunity to apply the principles, techniques and procedures practiced and learned in the classroom and lab to members of the community. Under the direction of the clinical supervisor, students are expected to review client intake information to determine possible contraindications; demonstrate proper ethics, client/therapist communication skills, proper draping techniques, and safety and sanitary precautions; and perform a full body massage utilizing basic Swedish massage techniques, properly documenting the session for the client's record. Students massage two to three clients consecutively. Students are expected to attend a weekly seminar.

II. EXPECTED LEARNING OUTCOMES AND RELATED COMPETENCIES:

Upon completion of the course, the student will be able to:

- 1. Effectively communicate demonstrating professionalism with clients before, during, and after the massage therapy session.
- 2. Properly assess client information.
- 3. Perform an appropriate full body massage according to the assessed needs of the client.
- 4. Effectively document client massage sessions.
- 5. Perform therapeutic massage in a business-like environment.

Outcome 1: Effectively communicate demonstrating professionalism with clients before, during, and after the massage therapy session.

- Competency 1.1: Demonstrate professionalism in clinical setting.
- Competency 1.2: Define and describe verbal and non-verbal communication technique.
- Competency 1.3: Identify potential blocks to communications.
- Competency 1.4: Recognize and describe professional boundaries.
- Competency 1.5: Apply knowledge of professional boundaries to the student-client relationship.

Outcome 2: Properly assess client information.

- Competency 2.1: Accurately review client intake form.

- Competency 2.4: Utilize appropriate massage techniques based on assessment findings.

Outcome 3: Perform an appropriate full body massage according to the assessed needs of the client.

- Competency 3.2: Respond to client needs by appropriately adjusting the massage sequence.
- Competency 3.3: Complete client session within allotted time.

- Competency 4.2: Briefly and concisely document subjective and objective client information.

XI. ATTENDANCE POLICY

<u>Attendance at all clinics is required.</u> All learning requires attendance and participation. Because of the nature of the therapeutic massage program, attendance is expected at all classes. It is also expected that the students will be present for the entire class. Students that are having problems with attendance will be asked to review their commitment to the therapeutic massage program.

<u>There are no excused absences.</u> If a third absence should occur in a class, the student will be required to meet with the program coordinator or the instructor in order to determine appropriate make-up work for time missed. A Learning Contract will be written and signed by the student and the instructor or program coordinator. Each additional absence will result in a 10% deduction from the final grade.

<u>Classes start on time with attendance taken.</u> Students who are late or who leave early will lose time. Each one half hour of class missed will be 25% of an absence. Please inform the instructor when you arrive late or leave early to receive accurate credit for your attendance or you will be assigned credit according to the instructor's estimate of your arrival and departure.

Emergency clinical absences must be made-up in order to graduate.
