#### I. CATALOG DESCRIPTION

This course continues the learning experiences of THM1218 Therapeutic Massage Clinical I, requiring the massage student to engage more deeply in critical thinking, safety, assessment, and documentation as well as understanding the scope of practice and roles of other health care disciplines. In the student clinical setting, therapeutic massage students have the opportunity to apply the massage principles, techniques and procedures in a professional therapeutic massage environment to members of the community. Under the direction of the clinical supervisor, students are expected to demonstrate proper ethics, client/therapist communication skills, proper draping techniques, sanitary precautions, perform a full body massage based on client needs and properly document the session for the client's record. Students are expected to massage three clients consecutively, to demonstrate professional behavior, and to attend a weekly seminar.

#### II. EXPECTED LEARNING OUTCOMES AND RELATED COMPETENCIES:

Upon completion of the course, the student will be able to:

- 1. Effectively communicate demonstrating professionalism with clients before, during and after the massage therapy session.
- 2. Properly assess client information.
- 3. Perform a full body massage to fit the assessed needs and interests of the client.
- 4. Develop an awareness of the availability of community healthcare professionals for client recommendation or referral.
- 5. Appropriately document the massage therapy session.

# Outcome 1: Effectively communicate demonstrating professionalism with clients before, during and after the massage therapy session.

Competency 1.1: Demonstrate professionalism in clinical setting.

Competency 1.2: Define and describe verbal and non-verbal communication technique.

Competency 1.3: Identify potential blocks to communications.

Competency 1.4: Recognize and describe professional boundaries.

relationship.

## Outcome 2: Properly assess client information.

Competency 2.1: Review client intake forms and notes in client folders integrating

client communications.

Competency 2.2: Visually assess and palpate obvious abnormalities during massage

therapy session.

Competency 2.3: Identify and analyze potential problem areas for client.

Competency 2.4: Formulate and flex massage therapy session based on assessed

findings.

# Outcome 3: Perform a full body massage to fit the assessed needs and interests of the client.

Competency 3.1: Demonstrate variations in Swedish massage techniques with client during session.

Competency 3.2: Demonstrate and perform passive range of motion and stretching techniques with client during session.

Competency 3.3: Accurately perform at least three (3) of various integrative

modalities, such as: reflexology, lymphatic drainage, triggerpoint therapy, myofascial release, acupressure, therapeutic touch, chakra

holds, etc.

# Outcome 4: Develop an awareness of the availability of community healthcare professionals for client recommendation or referral.

Competency 4.1: Identify community healthcare professionals and their scope of

practice.

Competency 4.2: Be able to list three (3) names of healthcare professionals in at least

four (4) different disciplines.

Competency 4.3: Create a network of community professional massage therapists for

personal support and possible client referral.

Competency 5.1: Understand legal principles of formal documentation.

Competency 5.2: Briefly and concisely document subjective and objective client

information.

Competency 5.3: Accurately document extent of massage session.

Competency 5.4: Integrate client feedback into documentation process.

Competency 5.5: Properly document abnormal findings identified during the massage

therapy session.

#### XI. ATTENDANCE POLICY

Attendance at all clinics is required. All learning requires attendance and participation. Because of the nature of the therapeutic massage program, attendance is expected at all classes. It is also expected that the students will be present for the entire class. Students that are having problems with attendance will be asked to review their commitment to the therapeutic massage program.

There are no excused absences. If a third absence should occur in a class, the student will be required to meet with the program coordinator or the instructor in order to determine appropriate make-up work for time missed. A Learning Contract will be written and signed by the student and the instructor or program coordinator. Each additional absence will result in a 10% deduction from the final grade.

Classes start on time with attendance taken. Students who are late or who leave early will lose time. Each one half hour of class missed will be 25% of an absence. Please inform the instructor when you arrive late or leave early to receive accurate credit for your attendance or you will be assigned credit according to the instructor's estimate of your arrival and departure.
