- C. A copy of the student's General Educational Development (GED) or High School Equivalency (HSE) certificate or GED or HSE transcript.
- D. An academic transcript that indicates the student successfully completed at least a two-year program that is acceptable for full credit toward a bachelor's degree.
- E. If state law <u>requires</u> a homeschooled student to obtain a secondary school completion credential for homeschool (other than a high school diploma or its recognized equivalent), then the student needs to provide a copy of the secondary school completion credential.

OR

If state law (IL) <u>does not require</u> a homeschooled student to obtain a secondary school completion credential for homeschool, then a transcript needs to be provided that is signed by the student's parent or guardian. The transcript must list the secondary school courses the student completed, as well as document the successful completion of a secondary school education in a homeschool setting.
