# Program Outcomes

- Explain the role of the surgical technician in the operating room and as part of the surgical team.
- Use proper medical terminology based in human anatomy, physiology, and medical conditions.
- Explain proper infection control procedures and practices required in patient care and in the sterile surgical environment.
- Identify the surgical instruments, equipment, supplies, materials, and medications used in general and specialized surgical procedures.
- Explain the procedures performed in preparing the patient for a surgical procedure, caring for the patient during a surgical procedure, and caring for the patient after the surgical procedure.
- Explain how to prepare the surgical environment for specific surgical procedures.
- Explain selected surgical procedures including the role of the surgical technologist.
- Discuss the medical laws and ethics related to surgical procedures and the surgical technologist position.
- Explain effective communication and patient care strategies used for a variety of surgical patients including those with special needs.

***Please note:** The State of Illinois does NOT require certification to become a Surgical Technician (or technologist); however, most hospitals and medical facilities do require certification and/or have their own specific requirements. We strongly suggest you research the certification and your goals to ensure they align.*

# FAQs

## **What is the difference between a Surgical Technician and Surgical Technologist?**

In Illinois, there is no specific requirement for either a Surgical Technician or a Surgical Technologist, so sometimes the term is used interchangeably. However, typically the difference between the two roles is based on the level of education, experience, etc. The program at Illinois Valley Community College prepares students for certification as a Surgical Technician. After 125 hours scrubbed in as a Surgical Technician, there is an opportunity to test to become a Surgical Technologist. We highly recommend researching the certifications to ensure they align with your goals (especially if you plan to move out of State in the future and/or have specific employers in mind).

# FAQs

## **Are there opportunity for clinical hours?**

Clinicals are not a requirement for this preparation program. Students interested in obtaining observation hours and/or applying for a clinical experience, may be eligible for OSF's Stipend Program.

## **Do I need to have a history in healthcare?**

No. The only requirement for this program is to have your high school diploma (or the equivalent). This is required to sit for certification.

Experience in healthcare may be helpful in landing a job upon successful completion of the program AND certification exam.

# FAQs

## **Do I need to purchase materials?**

No. The tuition cost includes all textbooks and materials. It does NOT include the cost of the certification exam(s). These exams vary from \$130.00 – \$200.00.

## **Is the class hands-on?**

Yes. Our Surgical Technician program is a mix of hands-on learning and lecture. Students may be required to do reading outside of class time to ensure they are prepared for their certification exam.



# FAQs

## **What if I start the class and realize it is not a good fit?**

Unfortunately, our Surgical Technician program does NOT offer refunds to students after they have attended class. Students may only receive a refund if they drop from the program 24 hours before class begins.

## **I cannot afford the full tuition amount, are payments an option?**

Because this is a noncredit program, preparing you for certification, tuition must be collected **in full**. A student is not considered registered until payment has been collected.

Although financial aid cannot be used, students may be eligible for the Noncredit Strategies at Work Grant, which will supplement up to 50% of tuition for students in the Surgical Technician program. *Please note that funding is not guaranteed and is based on financial need and available resources.*
