## STATEMENT OF QUALIFICATIONS FOR ARCHITECTURAL SERVICES

#### INSTRUCTIONS AND SPECIFICATIONS

The Illinois Valley Community College Board of Trustees is seeking Statement of Qualification submittals from architectural firms interested in performing professional services associated with the "Illinois Valley Community College Agricultural Education Facility," awarded to the College by the Economic Development Administration (EDA). The submittals will be used by the College to identify a shortlist of three (3) architectural firms to be interviewed. The College intends to award this professional service agreement to no more than one (1) architectural firm.

## **Anticipated Services Overview**

The selected Architect will be required to provide a team of professionals capable of delivering the services described in AIA Document B101-2007, the standard form agreement between Owner and Architect. The College asks that the architectural firms not include representatives from consultants as team members.

The project title and condensed scope of work are as follows:

Project: Illinois Valley Community College Agricultural Education Facility

Scope: This grant request includes the development of a new Agriculture Classroom & Lab Building along with associated sitework to support the Agriculture Program at Illinois Valley Community College.

## **RFQ Submission Requirements**

Submittals shall be on 8.5" x 11" paper and not exceed a total of 35 pages, including a cover letter and table of contents. Pages shall be single-sided using a minimum 10-point font. The Architect's Statement of Qualifications should include the following:

#### 1. Company Overview

Include the number of years in business, type of organization or company structure, location(s), number of total company employees, percentage of firm's work in designing educational facilities, and other relevant information.

#### 2. Project Team

Provide resumes of your team's key project personnel. Resumes should highlight qualifications relevant to this project. Indicate the number of years each person has been employed by the firm.

#### 3. Project Experience

Provide descriptions of comparable projects within the last 5 years. Include the following information: owner's name; project location; photos; building type (i.e., academic building, office building, etc.); construction costs; project completion dates; and other relevant information.

#### 4. References

Provide three (3) Owner references (include name, title, organization, address, phone number, and email address).

- 2. Design Capability and Familiarity with Facility Type
- 3. Project Management (Includes Willingness/Ability to Meet Time Requirements, Workload of the Firm, and Past Record of Meeting Project Budgets)
- 4. Chemistry between Team Members and Committee
- 5. Implementation of Emerging Technologies
- 6. Client Reference

#### **Submittal Instructions**

**Proposals are due** – On or before Wednesday, December, 2022, by 10:00 AM CST in Room C343, Building C, Office of the Director of Purchasing, Illinois Valley Community College, 815 N. Orlando Smith Road, Oglesby, IL 61348. Submittals received after this time will not be considered.

Please submit ten (10) copies of your submittal, as well as a flash drive containing a PDF file of your submittal. Submittals must be enclosed in a sealed envelope and clearly show the phrase "Request for Qualifications – Architect Services" and the Respondent's name. Qualifications submitted electronically will not be accepted.

## **Notice to Firms Submitting**


- 1. The cost of preparing and submitting to this RFQ is the responsibility of the proposing firm.
- 2. The College reserves the right to reject any submittals, waive any informality in them, amend the Request for Qualifications and the process itself, or discontinue the selection process at any time.
- 3. The College reserves the right to enter into negotiations with the most qualified firm based on the information provided in the Statement of Qualifications. If the College and the top-ranked firm are unable to develop a mutually satisfactory agreement, the College will terminate discussions with the top-ranked firm and will begin negotiations with the second-ranked firm. This process will continue until a mutually satisfactory agreement is developed.
- 4. The College's selection of the Architect and awarding of the professional services contract is dictated by EDA requirements, as well as subject to approval by the Illinois Valley Community College Board of Trustees, in accordance with state and federal law.
